### **VESTRY NOMINATIONS AND CONVENTION DELEGATES**

#### **NEWS FROM MARION C. PRICE TRUST FUND**

**Buying a Hearing Aid:** The Hearing Aid Sales Registration Law provides consumers purchasing a hearing aid in Pennsylvania with various rights and protections.

All hearing aid dealers and fitters must be registered with the Pennsylvania Department of Health and the registration certificate must be conspicuously posted in their office or place of business.

During the initial contact, hearing aid dealers and fitters must advise you that any fitting, examination or representation made by them regarding the hearing aid is not an examination, diagnosis or prescription by a person licensed to practice medicine and, therefore, must not be regarded as a medical opinion. You should receive this in writing.

During the six months prior to purchasing a hearing aid, you must have received an examination by an otologist, otolaryngologist or any licensed physician and a written recommendation stating that the use of a hearing aid may be beneficial. However, this rule does not apply to replacement parts, accessories, or a worn out or damaged hearing aid.

When certain medical conditions regarding your ears are found to exist, the dealer or fitter must suggest to you in writing that it is in your best interest to consult a licensed physician specializing in disease of the ear. They then may not sell you or fit you for a hearing aid without a written recommendation from a licensed physician that a hearing aid may be beneficial to you.

Before the dealer or fitter can provide any services to you, he or she must give you a disclosure agreement that must be explained to you in detail and be signed by you and the dealer or fitter. This disclosure agreement must contain a complete description of what the fitting procedure or process does and does not include and must itemize and disclose any and all fees.

Before the sale of any hearing aid to you, the dealer or fitter must give you a copy of the User Instructional Brochure for their hearing aid and reviews the contents with you.

At the time of the sale, the dealer or fitter must give you a written receipt signed by the dealer or fitter which contains important information regarding the hearing aid and the dealer or fitter. This receipt must also advise you that if your rights are violated, you may contact the State Attorney General's Bureau of Consumer Protection or the Pennsylvania Department of Health. The sale of the hearing aid must be accompanied by a 30-day money-back written guarantee. This guarantee must allow you to return the hearing aid within 30 days of the date of delivery in the same condition as when purchased, ordinary wear and tear excluded. You will be entitled to a refund of the purchase price of the hearing aid and accessories within 30 days of their return. However, a dealer may retain a cancellation fee which may not exceed the lesser of 10% of the purchase price or \$150.

**Operation We Care:** November 17 will be our last mailing for Operation We Care. Since we started this project in 2007, we have mailed almost under 400 boxes, weighing about 4,300 pounds to about 180 local servicemen and women stationed in Iraq & Afghanistan. *Medicare Open Enrollment:* October 15 – December 7, 2015 is open enrollment period. It is recommended that, no matter how satisfied you are with your current Medicare Part D drug plan you review it annually to be sure it is still the best plan for you, because plans can change the deductible amounts, the co-pays, the formularies and the coverage areas.

**Pre – Diabetes:** Before people develop type 2 diabetes, they almost always have "prediabetes": blood glucose levels that are higher than normal but not yet high enough to be diagnosed as diabetes.

There are no clear symptoms of pre diabetes (urinating often, feeling very thirsty, feeling very hungry, extreme fatigue, blurry vision, cuts/bruises that are slow to heal and weight loss) so you may have it and not know it.

If you have pre-diabetes, you should be checked for type 2 diabetes every one to two years. You are pre-diabetic if you have an A1C of 5.7%-6.4% or a fasting blood sugar of 100-125. You will not develop type 2 diabetes automatically if you have diabetes. For some people with pre-diabetes, early treatment can actually return blood glucose levels to the normal range. Research shows that you can lower your risk for type 2 diabetes by losing 10-15 pounds of your body weight and exercising moderately 30 minutes a day, five days a week.

# **RESTORATION PROJECT**

We are almost done. We were waiting for a second bid for the final coat and sealer for the 16th Street entrance. The one estimate is \$3,550. All of the drain work is done. The new sidewalks, the new curbing, and the re-sloping of the road were very effective in deterring the water from entering the property from 16th Street and from West End Avenue. The pond was cleaned out; unfortunately, it still seems to want to be a wetland instead of a pond. The shallowness of the pond is more conducive to vegetation growth. Final numbers will be provided in the next issue once the road work is complete. No additional donations came in for the road works; however, the two co-chairs are prepared to put in the money personally just to get the project finished. It will come in on budget of roughly \$60,000. The good news was that all funds were raised privately and did not come from the cemetery's operating budget.

In the beginning of September, a person from DCNR conservation district from Harrisburg came to the cemetery to see the pond area and to offer suggestions. He did provide some aquatic plant ideas and some planting suggestions for the side banks. Most likely because of the lateness of the year, the plantings will be postponed until early spring. We'll keep you posted on what will be done. We may try one more time to have the side banks dug just to get the invasive plant growth back out of the pond.

## HAPPY THANKSGIVING AND MERRY CHRISTMAS

The grounds of the cemetery are at the grand finale of what was once again a spectacular fall season of brilliant, colorful foliage. No matter what season the property is visited, there is always something wonderful to see. This peaceful acreage of nature, offers respite to a very busy and hectic schedule. If you have the time and the opportunity, stop and take a walk. With the Thanksgiving and Christmas quickly approaching, we, the cemetery board, thank all of you, our supporters, who sponsored a tree for Arbor Day, volunteered help on Baber Day, contributed to the restoration project, or sent money in to the endowment account. And our laborers, Bob, Tom, and Randy are phenomenal. They keep the grass cut short, the weeds cut down, the litter and papers cleaned up, the mounds of leaves reasonably raked and vacuumed, and the property tidy. We did have one unexpected bump in the road, when our lawn mower died, and had to be replaced at a cost of \$8,110. And a larger number than normal of trees had to be cut down or needed their large dead limbs pruned. And there is always much needed work to be done on the chapel. If you can't think of an idea for Christmas gift giving, consider sending in a monetary charitable gift to the cemetery to help defray the expenses of the new lawn mower purchase or of the tree cutting or pruning, or towards the repairs of the chapel wall.


